Remote auditing has been thrust into the limelight given the circumstances surrounding the COVID-19 pandemic. However, remote auditing has been around for well over a decade. Its popularity has been spurred by advances in technology and the globalization of economies. The purpose of auditing is to verify the conformance of an organization's processes and management system to defined requirements.
